ARTICLES OF CONVERSION  
OF

Pursuant to the provisions of Article 5.18 of the Texas Business Corporation Act, Wilson Industries, Inc., a Texas corporation (the Converting Entity), hereby executes the following Articles of Conversion:

1. (A) The name of the converting entity is Wilson Industries, Inc., a Texas corporation (the Converting Entity).
  - (B) A Plan of Conversion (the Plan) for the Converting Entity has been approved by the shareholders of the Converting Entity.
  - (C) An executed copy of the Plan is currently on file at the principal place of business of the Converting Entity, which is located at P.O. Box 60068, 16740 Hardy Street, Houston, Texas. An executed copy of the Plan will be on file, and will continue to be on file, at the principal place of business of the Converted Entity, which will be located at P.O. Box 60068, 16740 Hardy Street, Houston, Texas.
  - (D) An executed copy of the Plan will be provided, on written request and without cost, to any shareholder of the Converting Entity or any partner of the Converted Entity, by the Converting Entity, if such request is made prior to the conversion becoming effective, or by the Converted Entity, if such request is made after the conversion becomes effective.
2. The number of outstanding shares of the Converting Entity is one hundred (100) shares at a par value of \$1.00 per share.
  3. A total of 100 shares voted for the Plan. No shares voted against the Plan.
  4. Converted Entity assumes liability for payment of all fees and franchise taxes arising in accordance with the filing of these Articles of Conversion.
  5. The approval of the Plan of Conversion was duly authorized by all action required by the laws under which the Converting Entity was incorporated.
