**NOTICE OF RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**WHEREAS**, the Agent now desires to terminate and release the entirety of its security interest in the Intellectual Property;

**NOW, THEREFORE**, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Intellectual Property pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this release, the Agent hereby states as follows:

The Agent hereby terminates, releases and discharges its security interest in the Intellectual Property, and re-assigns and releases to the Grantors all right, title and interest that the Agent has in and to the Intellectual Property and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including, without limitation, all goodwill associated in any way with such Intellectual Property; and all rights corresponding thereto associated with such Intellectual Property.

This release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
