
RECITALS:

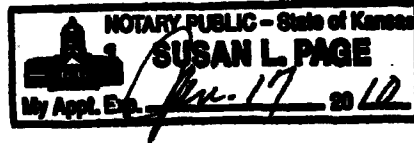
