RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL  
(SECOND LIEN)

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of December 3, 2010, is made by GOLDMAN SACHS LENDING PARTNERS LLC, as administrative agent (the "Administrative Agent"), in favor of the Borrower (as defined below) and certain of its Subsidiaries. All terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement.

WHEREAS, SIX FLAGS THEME PARKS INC., (the "Borrower"), and the Administrative Agent entered into that certain Second Lien Credit Agreement, dated as of April 30, 2010 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, the Administrative Agent and the various financial institutions party thereto as lenders thereunder (each individually a "Lender", and collectively the "Lenders"), pursuant to which Credit Agreement the Lenders made credit extensions to the Borrower;

WHEREAS, in connection with the Credit Agreement, and pursuant to (i) the Second Lien Guarantee and Collateral Agreement, dated as of April 30, 2010 (the "Guarantee and Collateral Agreement"), among the Borrower, Six Flags Entertainment Corporation, Six Flags Operations Inc., the Administrative Agent, the other agents named therein and the other grantors party thereto, (ii) the Grant of Second Lien Security Interests in Trademark Rights, dated as of April 30, 2010, between the Borrower and the Administrative Agent, (iii) the Grant of Second Lien Security Interests in Trademark Rights, dated as of April 30, 2010, between Fiesta Texas, Inc. ("Fiesta Texas"), a Texas corporation and the Administrative Agent, (iv) the Grant of Second Lien Security Interests in Trademark Rights, dated as of April 30, 2010, between Funtime, Inc. ("Funtime"), a Ohio corporation and the Administrative Agent, and (v) the Grant of Second Lien Security Interest in Patent Rights, date April 30, 2010, between the Borrower and the Administrative Agent (collectively, the "Security Agreements"), the Borrower, certain of the Borrower's Subsidiaries, Fiesta Texas and Funtime granted security interests in certain Intellectual Property (as defined in the Guarantee and Collateral Agreement) owned by the Borrower, the Subsidiaries of the Borrower, Fiesta Texas and Funtime, including those, listed on Annex I attached hereto (collectively, the "Patent and Trademark Collateral");

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto; and

WHEREAS, the Administrative Agent, on behalf of itself and the Secured Parties, desires to hereby release its security interest in and to the Patent and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent, on behalf of itself and the Secured Parties, agrees, for the benefit of the Borrower, the Borrower's Subsidiaries, Fiesta Texas and Funtime as follows:

1. Release of Security Interest. The Administrative Agent, on behalf of itself and the Secured Parties, hereby **RELEASES AND DISCHARGES** all of its lien on and security interest in all of the Borrower's, the Borrower's Subsidiaries', Fiesta Texas's and Funtime's right, title and interest in and to the Patent and Trademark Collateral, whether granted pursuant to the Credit Agreement, the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement or the Security Agreements, and the Administrative Agent, on behalf of itself and the Secured Parties, hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent and/or the Secured Parties may have in or to the Patent and Trademark Collateral to the Borrower, each of the Borrower's applicable Subsidiaries, Fiesta Texas and Funtime.

2. Further Assurances. The Administrative Agent, on behalf of itself and the Secured Parties, agrees, at the Borrower's expense, to cooperate with the Borrower, the Borrower's Subsidiaries, Fiesta Texas and Funtime and to provide the Borrower, the Borrower's Subsidiaries, Fiesta Texas and Funtime with any information and additional authorization and to timely take, or cause to be taken, all actions, in each case as may be reasonably required or desirable to carry out the provisions of, consummate, and make effective the release of the Administrative Agent's security interest in the Patent and Trademark Collateral described herein.

3. Counterparts. This Release may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument; signature pages may be detached from multiple separate counterparts and attached to a single counterpart so that all signature pages are physically attached to the same document.

4. Governing Law. This Release and the rights and obligations of the parties under this Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, without regard to its conflicts of law provisions (other than Section 5-1401 and Section 5-1402 of the New York General Obligation Laws).
