TRADEMARK ASSIGNMENT AGREEMENT

THIS AGREEMENT, effective on 12/1/10, 2010, is between Buff Park Property LLC, a Texas Limited Liability Company ("BPP"), having its principal place of business at 4001 Gulf Freeway, Houston, Texas 77005 and Finco, Inc., a Texas corporation ("Finco"), having its principal place of business at 4001 Gulf Freeway, Houston, Texas 77005.

WHEREAS, Finco has been using the trademarks and service marks referenced in Appendix A (the "Marks") under license from BPP;

WHEREAS, BPP wishes to assign the trademarks and service marks to Finco, and Finco wishes to accept such assignment;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

BPP hereby assigns, transfers, and conveys to Finco all right, title, and interest in and to the Marks, together with the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof.


In the event at any time after the effective date hereof any further action is necessary to record this Agreement, to record the assignment of the Marks in their respective trademark offices in the name of Finco, or to validate the assignment of the Marks, BPP shall execute the appropriate document at the request of Finco and at the sole expense of Finco.

This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.

IN WITNESS WHEREOF, the parties have caused this Agreement to be executed on the date first above written, by and through their duly authorized agents.


