**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of December 22, 2010, is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, in its capacity as the Collateral Agent for the Secured Parties (the "Collateral Agent"), pursuant to the termination of the Credit Agreement, dated as of February 24, 2010 by and among CENTRAL PURCHASING, LLC, a California limited liability company, HARBOR FREIGHT TOOLS USA, INC., a Delaware corporation (jointly and severally, the "Borrowers"), the Collateral Agent, and the other persons party thereto (as amended, supplemented, replaced or otherwise modified from time to time, the "Credit Agreement"). Capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Credit Agreement.

W I T N E S S E T H

WHEREAS, the Borrowers, the other grantors party thereto (together with the Borrowers, the "Grantors") and the Collateral Agent are parties to the Pledge and Security Agreement, dated as of February 24, 2010 (as amended, supplemented, replaced or otherwise modified from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, certain of the Grantors executed the Intellectual Property Security Agreement by and among such Grantors and the Collateral Agent for the Secured Parties, dated February 24, 2010 (as amended, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement") and recorded with the U.S. Patent and Trademark Office on February 25, 2010 at Reel/Frame Nos. 23985/0669 and 4156/0637, pursuant to which such Grantors granted to the Collateral Agent, for itself and for the ratable benefit of the Secured Parties, a security interest in and continuing lien on all of such Grantors' right, title and interest in, to and under all Patents (as defined in the Intellectual Property Security Agreement) (the "Patent Collateral"), Trademarks (as defined in the Intellectual Property Security Agreement) (the "Trademark Collateral"), Copyrights (as defined in the Intellectual Property Security Agreement) (the "Copyright Collateral") and Exclusive Copyright Licenses (as defined in the Intellectual Property Security Agreement) (the "Copyright License Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

The Collateral Agent, on its own behalf and on behalf of the Secured Parties, hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired through the Intellectual Property Security Agreement, or otherwise, in and to the Patent Collateral, Trademark Collateral, Copyright Collateral, Copyright License Collateral and any other Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement), including the patents and patent applications, and the trademark and service mark registrations listed on Schedule I attached hereto and incorporated herein by reference (collectively, the "Released Collateral").

The Collateral Agent authorizes the recordation of this Release with the U.S. Patent and Trademark Office and any other applicable registry, the filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Collateral Agent's Lien upon and security interest in the Patent Collateral and the Trademark Collateral by the Grantors or any person authorized or designated by the Grantors, and any such recordation or filing shall be deemed to have been authorized by the Collateral Agent.

The Collateral Agent agrees to provide the Grantors with any additional authorization necessary to effect the release of its security interest in the Released Collateral.


