FIRST LIEN TRADEMARK SECURITY RELEASE

This FIRST LIEN TRADEMARK SECURITY RELEASE (this "Release") is made as of December 6, 2010 by JPMorgan Chase Bank, N.A. (as successor in interest to Bear Stearns Corporate Lending Inc.), in its capacity as Administrative Agent for the Secured Parties (in such capacity, the "Administrative Agent").

WITNESSETH:

WHEREAS, reference is made to (a) the First Lien Credit Agreement, dated as of May 11, 2007 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Credit Agreement"), among McKechnie Aerospace Holdings, Inc. ("Holdings"), McKechnie Aerospace DE, Inc. (the "Borrower"), the lenders from time to time party thereto, JPMorgan Chase Bank, N.A. (as successor in interest to Bear Stearns Corporate Lending Inc.), as administrative agent, and the other agents and arrangers party thereto, (b) the First Lien Guarantee and Collateral Agreement, dated as of May 11, 2007 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Guarantee and Collateral Agreement"), by and among Holdings, the Borrower, McKechnie Aerospace US LLC (formerly known as Melrose US 3 LLC), McKechnie Aerospace Investments, Inc. (formerly known as McKechnie Investments, Inc.), Hartwell Corporation, Valley-Todeco, Inc. and Western Sky Industries, LLC (collectively, the "Grantors" and each, individually, a "Grantor"), and the Administrative Agent, and (c) the First Lien Trademark Security Agreement, dated as of May 11, 2007 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Security Agreement"), among the Grantors and the Administrative Agent;

WHEREAS, unless otherwise noted, each capitalized term used herein but not otherwise defined shall have the meaning ascribed to such term in the Guarantee and Collateral Agreement;

WHEREAS, pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement, each Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) owned by such Grantor;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 15, 2007 at Reel/Frame Nos. 003541/0865, 003541/0910 and 003541/0853 and on August 15, 2007 at Reel/Frame No. 003602/0477; and

WHEREAS, in connection with the repayment of all outstanding indebtedness and other monetary obligations of the Grantors in respect of the Loan Documents (as defined in the Credit Agreement) and the termination of all "Commitments" under and as defined in the Credit Agreement, the security interests under the Guarantee and Collateral Agreement and the Trademark Security Agreement have been released, and the Guarantee and Collateral Agreement and the Trademark Security Agreement have been terminated.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent does hereby agree as follows:

The Administrative Agent does hereby release, transfer and assign, without representation or warranty and without recourse, and at the Grantors' sole cost and expense, unto each Grantor, its security interest in all of such Grantor's right, title and interest in and to the Trademarks, including the registered trademarks set forth on Schedule A hereto and incorporated herein by reference (the "Released Collateral").

The Administrative Agent authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry or government office necessary to effect the release of its security interest in the Released Collateral, in each case at the Grantors' sole cost and expense.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
