TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is entered into as of December 16, 2010, by and between Arrow-Intechra LLC, a Delaware limited liability company ("Assignee"), and Intechra Group, LLC, a Delaware limited liability company ("Assignor").

W I T N E S S E T H:

WHEREAS, Assignor is the current owner of record of United States trademark registrations and trademarks listed on Schedule A hereto (hereinafter, "Registrations" and "Trademarks", respectively);

WHEREAS, Assignor is the current owner of record of the unregistered trademarks, service marks, trade names, and corporate names listed on Schedule B hereto (hereinafter, "Unregistered Marks and Names");

WHEREAS, Assignee and Assignor, among others, entered into an Asset Purchase Agreement dated as of November 22, 2010 (as amended, modified or supplemented from time to time in accordance with its terms, the "Asset Purchase Agreement"; capitalized terms used by not defined herein shall have the meanings ascribed to them in the Asset Purchase Agreement), pursuant to which, Assignor has agreed to sell, transfer, convey, assign and deliver to Assignee, and Assignee has agreed to purchase from Assignor the Assets, including the Trademarks and Unregistered Marks and Names, and Assignee has agreed to assume the Assumed Liabilities; and

WHEREAS, Assignee desires to obtain from Assignor and Assignor desires to transfer, assign and otherwise convey to Assignee any and all of Assignor's rights, title and interest in, to and under the Trademarks, Registrations and Unregistered Marks and Names, and the good will associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor does hereby transfer, assign and otherwise convey to Assignee, and Assignee hereby accepts the assignment and transfer of, all of Assignor's right, title and interest in, to and under (1) the Trademarks, together with the goodwill associated with and symbolized by the Trademarks, and all marks consisting of or comprising the Trademarks, and the Registrations, including any renewals and extensions thereof that may be secured under the laws of the United States and all foreign countries, now or hereafter in effect, together with all income, royalties or payments due or payable with respect to the Trademarks, (2) the Unregistered Marks and Names, together with the goodwill associated with and symbolized by the Unregistered Marks and Names, and all marks consisting of or comprising the Unregistered Marks and Names, together with all income, royalties or payments due or payable with respect to the Unregistered Marks and Names, and (3) all rights to sue for the infringement of the foregoing rights, including all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademarks or the Unregistered Marks and Names, with the right to sue

for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns, affiliates or other legal representatives.

2. Assignor hereby agrees to perform all acts reasonably necessary and appropriate, at Assignee's expense, to vest in Assignee, or to its successors and assigns, the rights hereby transferred, assigned and conveyed, and to promptly execute all papers as may be reasonably requested by Assignee in order to obtain assignment documents in recordable form and to perfect the rights, title and interest hereby transferred, assigned and conveyed, including, but not limited to, effectuating the transfer of the Trademarks by filing assignment documents in recordable form in each jurisdiction where trademark registrations or applications may be issued or pending, and distributing copies of the completed and receipted assignment recordation documents to Assignee.

3. This Assignment shall inure to the benefit of the successors and assigns of Assignee, and shall be binding upon the successors and assigns of Assignor.

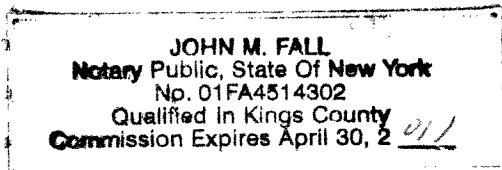
