**RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of ~~DECEMBER 1~~, 2010 ("Release Date") in favor of ESCORT INC. (the "Pledgor") by AMERICAN CAPITAL, LTD. (as successor by merger to AMERICAN CAPITAL FINANCIAL SERVICES, INC.), in its capacity as administrative agent (in such capacity, the "Administrative Agent").

**WHEREAS**, the Pledgor is a party to that certain Second Lien Security Agreement, dated as of November 18, 2005 (the "Security Agreement") in favor of Canadian Imperial Bank of Commerce, acting through its New York agency (the "CIBC");

**WHEREAS**, pursuant to the Security Agreement, the Pledgor granted to the CIBC for the benefit of the Secured Parties (as defined in the Security Agreement) a lien on and security interest in certain intellectual property;

**WHEREAS**, the CIBC and the Administrative Agent are party to a Successor Agent and Amendment Agreement, dated as of July 30, 2009, in which the CIBC assigned and delegated to the Administrative Agent all the rights, powers, discretion and privileges of the CIBC, and further, the CIBC assigned and delegated to the Administrative Agent the obligations, responsibilities and duties of the CIBC in accordance with the terms of the Credit Agreement (as defined in the Security Agreement) and the Security Agreement;

**WHEREAS**, in connection with the Security Agreement, Pledgor entered into that certain Second Lien Trademark Security Agreement, dated as of July 30, 2009 (the "Trademark Security Agreement") for the purpose of recording the security interest granted with respect to the trademark registrations and applications of the Pledgor, including those items set forth on Schedule A hereto (the "Pledged Collateral") with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 11, 2009, at Reel 4042, Frame 0377; and

**WHEREAS**, the Pledgor has paid all of its outstanding indebtedness to the Administrative Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and the Secured Parties, hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests and liens it has against the Pledged Collateral, and (iii) re-assigns to the Pledgor any right, title and interest it may have in, to and under the Pledged Collateral to the Pledgor.

The Administrative Agent shall, at the Pledgor's expense, take all further actions, and provide to the Pledgor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor to more fully and effectively effectuate the purposes of this Release.
