EXECUTION VERSION**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This TERMINATION AND RELEASE, dated as of September 30, 2010, is made by Bank of America, N.A., as successor to Lehman Commercial Paper, Inc., as administrative agent (the "Agent") for itself and the several banks and other financial institutions or entities (the "Lenders") from time to time parties to the Credit Agreement, dated as of January 27, 2005 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Alliance Laundry Holdings LLC, Alliance Laundry Systems LLC (the "Company"), the Agent, the Lenders and the other parties thereto.

WITNESSETH

WHEREAS, pursuant to that certain (i) Guarantee and Collateral Agreement, dated as of January 27, 2005 (the "Guarantee and Collateral Agreement"), (ii) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of January 27, 2005 and (iii) that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of March 12, 2009 (the Guarantee and Collateral Agreement together with the two Notices and Confirmations, collectively, the "Security Agreements") the Company granted the Agent a security interest in and to its Trademarks (as defined in the Guarantee and Collateral Agreement) including all applications and registrations therefor, including the goodwill and the trademark applications and registrations therefore set forth on Schedule A attached hereto and incorporated by reference (collectively, the "Trademark Collateral");

WHEREAS, the Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of January 27, 2005 was recorded in the Trademark Division of the United States Patent and Trademark Office on February 3, 2005, at Reel 3021, Frame 0658; and

WHEREAS, the Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of March 12, 2009 was recorded in the Trademark Division of the United States Patent and Trademark Office on March 12, 2009, at Reel 3951, Frame 0786;

WHEREAS, the Agent acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreements have been made; and

WHEREAS, Company has requested that the Agent release its security interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, the Agent hereby states as follows:

1. The Agent, hereby terminates, releases and discharges its security interest in the Trademark Collateral, and all of its right, title and interest in and to the security interests granted to Agent in the Trademark Collateral pursuant to the Security Agreements.

2. The Agent agrees to execute and deliver and provide Company with any information and additional authorization and take all other actions necessary or reasonably desirable to effect the release of the Agent's security interest in the released Trademark Collateral.

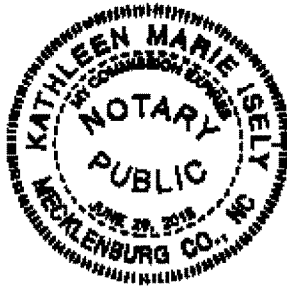
