TRADEMARK ASSIGNMENT

including the goodwill, corresponding thereto throughout the respective countries where ASSIGNOR holds rights in the Marks.

ASSIGNOR agrees to immediately cease using the Marks and further agrees, without further consideration, to cause to be performed such lawful acts and to execute such further documents regarding the rights assigned, transferred and sold herein, as reasonably requested by ASSIGNEE or its successors or assigns.

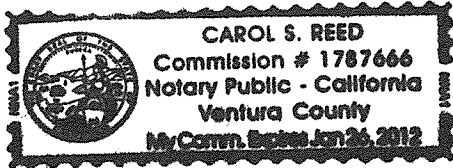
