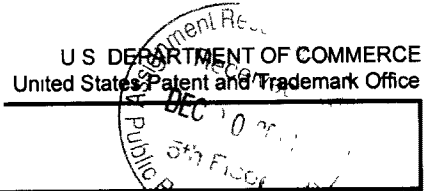


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all of the Intellectual Property, as herein provided.
