RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL
(SECOND LIEN)

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of November 19, 2010, is made by WILMINGTON TRUST FSB (successor to CapitalSource Finance LLC), as collateral agent for the Secured Parties (as defined in the Credit Agreement referred to below) (the "Collateral Agent"), in favor of the Borrower (as defined below) and certain of its Subsidiaries. All terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement.

WHEREAS, AZ CHEM US INC. (the "Borrower"), and the Collateral Agent entered into that certain Second Lien Credit and Guaranty Agreement, dated as of February 28, 2007 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, the Collateral Agent and the various financial institutions party thereto as lenders thereunder (each individually a "Lender", and collectively the "Lenders"), pursuant to which Credit Agreement the Lenders made credit extensions to the Borrower;

WHEREAS, in connection with the Credit Agreement, and pursuant to (i) the Second Lien Pledge and Security Agreement, dated as of February 28, 2007 (the "Pledge and Security Agreement"), among the Borrower, AZ Chem US Holdings Inc. ("U.S. Holdings"), the other grantors party thereto and the Collateral Agent, (ii) the Second Lien Patent Security Agreement, dated as of February 28, 2007 (the "Patent Security Agreement"), between Arizona Chemical Company, LLC (f/k/a Arizona Chemical Company) ("ACC") and the Collateral Agent, and (iii) the Second Lien Trademark Security Agreement, dated as of February 28, 2007 (the "Trademark Security Agreement") and together with the Pledge and Security Agreement and the Patent Security Agreement, collectively, the "Security Agreements"), between ACC and the Collateral Agent, the Borrower, U.S. Holdings and certain of the Borrower's Subsidiaries granted security interests in certain Intellectual Property (as defined in the Pledge and Security Agreement) owned by the Borrower, U.S. Holdings and the Subsidiaries of the Borrower listed on Annex I attached hereto (collectively, the "Patent and Trademark Collateral"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto; and

WHEREAS, the Collateral Agent, on behalf of itself and the Secured Parties, desires to hereby release its security interest in and to the Patent and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent, on behalf of itself and the Secured Parties, agrees, for the benefit of the Borrower, U.S. Holdings and certain of the Borrower's Subsidiaries, as follows:

1. Release of Security Interest. The Collateral Agent, on behalf of itself and the Secured Parties, hereby **RELEASES AND DISCHARGES** all of its lien on and security interest in all of the Borrower's, Holding's and each applicable Subsidiary's right, title and interest in

and to the Patent and Trademark Collateral, whether granted pursuant to the Credit Agreement, the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement or the Security Agreements, and the Collateral Agent, on behalf of itself and the Secured Parties, hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent and/or the Secured Parties may have in or to the Patent and Trademark Collateral to the Borrower, U.S. Holdings and each of the Borrower's applicable Subsidiaries.

2. Further Assurances. The Collateral Agent, on behalf of itself and the Secured Parties, agrees, at the Borrower's expense, to cooperate with the Borrower, U.S. Holdings and the Borrower's Subsidiaries and to provide the Borrower, U.S. Holdings and the Borrower's Subsidiaries with any information and additional authorization and to timely take, or cause to be taken, all actions, in each case as may be reasonably required or desirable to carry out the provisions of, consummate, and make effective the release of the Collateral Agent's security interest in the Patent and Trademark Collateral described herein.

3. Counterparts. This Release may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument; signature pages may be detached from multiple separate counterparts and attached to a single counterpart so that all signature pages are physically attached to the same document.

4. Governing Law. This Release and the rights and obligations of the parties under this Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, without regard to its conflicts of law provisions (other than Section 5-1401 and Section 5-1402 of the New York General Obligation Laws).
