SECURITY AGREEMENT / NOTICE OF SECURITY INTEREST (TRADEMARKS)

THIS SECURITY AGREEMENT/NOTICE OF SECURITY INTEREST (TRADEMARKS) (this "Agreement") entered into as of February 4, 2011, is made by BLITZ U.S.A., INC., an Oklahoma corporation (the "Grantor") in favor of BOKF, NA, d/b/a Bank of Oklahoma (the "Administrative Agent") for the benefit of the Lenders (as defined below).

WHEREAS, Grantor has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Exhibit 1, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office, as more fully set forth on Exhibit 1 (the "<u>Trademarks</u>"); and

WHEREAS, pursuant to the First Amended and Restated Credit Agreement dated as of even date herewith (such agreement, as amended, restated, supplemented or otherwise modified from time to time, being hereinafter referred to as the "Credit Agreement") among Blitz Acquisition, LLC, a Delaware LLC, Grantor, Blitz RE Holdings, LLC, a Delaware LLC, and F3 Products, Inc., a Delaware corporation, as borrowers (the "Borrowers"), and the lenders party thereto (each a "Lender" and collectively, the "Lenders"), the Administrative Agent, have agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein; and
