**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARK RIGHTS (this "Termination and Release") is made as of February 10, 2011 by and among COLLINS INDUSTRIES, INC., a Missouri corporation having a mailing address at 15 Compound Drive, Hutchinson, Kansas 67502-4349 ("Collins"), COLLINS BUS CORPORATION, a Kansas corporation having a mailing address at 415 West Sixth, South Hutchinson, Kansas 67505 ("Bus"), WHEELED COACH INDUSTRIES, INC., a Florida corporation having a mailing address at P.O. Box 677339, Orlando, Florida 32867-7339 ("WCI"), CAPACITY OF TEXAS, INC., a Texas corporation having a mailing address at 401 Capacity Drive, Longview, Texas 75604-5341 ("Capacity"), WORLD TRANS, INC., a Kansas corporation having a mailing address at 415 West Sixth, South Hutchinson, Kansas 67505 ("World Trans"), MOBILE PRODUCTS, INC., a Kansas corporation having a mailing address at 401 Capacity Drive, Longview, Texas 75604-5341 ("Mobile Products", and together with Collins, Bus, WCI, Capacity and World Trans, the "Debtors" and each a "Debtor") and ORIX CORPORATE CAPITAL INC., formerly known as ORIX Finance Corp., as agent for Lenders (as defined below) having a mailing address at 1717 Main Street, Suite 1100, Dallas, Texas 75201 ("Secured Party").

WHEREAS, the Debtors, certain other Loan Parties and the Secured Party entered into a Loan and Security Agreement, dated as of October 31, 2006 (the "Loan Agreement"), with the various financial institutions named therein or which thereafter became a party thereto (collectively, "Lenders" and each a "Lender") pursuant to which a security interest (the "Security Interest") was granted in certain Collateral (as defined in the Collateral Assignment);

WHEREAS, pursuant to the Trademark Collateral Security Agreement, dated as of October 31, 2006, made by the Debtors in favor of the Secured Party (the "Collateral Assignment"), the Debtors, by reference to the Loan Agreement, reaffirmed their intent to grant a Security Interest to the Secured Party in the Collateral, including the trademarks specifically listed on Schedule A attached hereto;

WHEREAS, the Security Interest was recorded in the United States Patent and Trademark Office on December 12, 2006, at Reel 3442 and Frame 0321;

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Loan Agreement and the Collateral Assignment, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby states as follows:

1. Release of Security Interest. The Secured Party hereby irrevocably terminates, releases and discharges the entirety of its Security Interest in the Collateral, and any

right, title or interest the Secured Party may have in such Collateral shall hereby cease and become void.

2. Further Assurances. The Secured Party hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

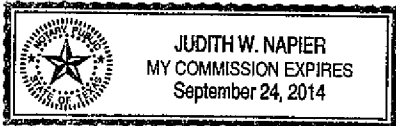
