**TRADEMARK ASSIGNMENT**

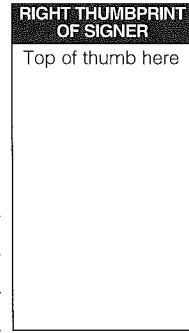
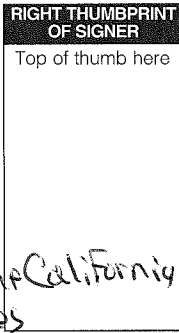
