RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE, dated as of January 25. 2011, is made by NEXBANK, SSB, as Collateral Agent (the "Grantee"), in connection with the termination of the Second Lien Pledge and Security Agreement, dated as of October 23, 2007 (as amended from time to time, the "Security Agreement"), by and among Carey International, Inc. ("Carey"), the other grantors party thereto (together with Carey, the "Grantors") and the Grantee. Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Security Agreement.

WITNESSETH

WHEREAS, under the terms of the Security Agreement, each Grantors granted to the Grantee a security interest in and continuing lien on all of such Grantor's right, title and interest in, to and under certain property and assets of such Grantor, including the Trademark Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, (i) Carey and certain other Grantors executed that certain Second Lien Trademark Security Agreement, dated October 23, 2007 and recorded with the United States Patent and Trademark Office on October 31, 2007 at Reel/Frame No. 3650/0872 (the "Initial Trademark Security Agreement") and (ii) Manhattan International Limousine Network LLC executed that certain Second Lien Trademark Security Agreement, dated February 7, 2008 and recorded with the United States Patent and Trademark Office on February 11, 2008 at Reel/Frame No. 3716/0754 (together with the Initial Trademark Security Agreement, the "Trademark Security Agreements"), pursuant to which such Grantors granted to the Grantee a security interest in all of such Grantors' right title and interest in, to and under (a) all of the Trademarks and Trademark Licenses to which any such Grantor is a party, (b) all reissues, continuations or extensions of the foregoing, (c) all goodwill of car service business connected with the use of, and symbolized by, each such Trademark and Trademark License, and (d) all products and proceeds of the foregoing including, without limitation, any claim by any such Grantor against third parties for past, present or future (1) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (2) injury to the goodwill associated with any Trademark or Trademark licensed under any Trademark License (collectively, the " (collectively, the "Trademark Collateral"); and

WHEREAS, the Security Agreement and the Trademark Security Agreements have been terminated in accordance with the terms of that certain Restructuring Agreement, dated as of January 25, 2011, by and among the Grantors, the Grantee and certain other parties thereto;

NOW, THEREFORE, in consideration of the foregoing, the Grantee hereby agrees as follows:

Section 1. <u>Release</u>. The Grantee hereby releases, transfers and assigns, without recourse, unto the Grantors, all of its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark and service mark registrations listed on <u>Schedule I</u> attached hereto and incorporated herein by reference.

Section 2. <u>Recordation</u>. The Grantee authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry, the filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Grantee's security interest in the Trademark Collateral by the Grantors or any persons authorized or designated by the Grantors, and any such recordation or filing shall be deemed to have been authorized by the Grantee.

Section 3. <u>Further Assurances</u>. The Grantee agrees to provide the Grantors with any additional authorized necessary to effect the release of its security interest in the Trademark Collateral.
