**ARTICLES OF AMENDMENT**  
**TO THE**  
**ARTICLES OF AMENDMENT AND RESTATEMENT**  
**OF**  
**WELLDOC COMMUNICATIONS, INC.**

**WELLDOS COMMUNICATIONS, INC.**, a Maryland corporation (hereinafter referred to as the "Corporation"), having its principal office in Baltimore City, Maryland, hereby certifies to the State Department of Assessments and Taxation of Maryland ("SDAT") that:

**FIRST:** The Articles of Incorporation of Well Doc Communications, Inc., a Maryland corporation, was accepted by the State Department of Assessments and Taxation ("SDAT") on March 21, 2005, and Amended on July 8, 2005, and further Amended on May 1, 2006 to change the name of the Corporation to WellDoc Communications, Inc., and further amended by filing Articles of Amendment and Restatement with SDAT (the "Amended and Restated Articles") on July 6, 2007. Article Fourth of the Amended and Restated Articles is hereby amended as follows:

**"FOURTH:** The name of the Corporation (the "Corporation") is:  
**"WELLDOC, INC."**

The remainder of Article Fourth shall remain unchanged and in full force and effect.

**SECOND:** The Articles of Amendment set forth herein have been approved by the Board of Directors of the Corporation, all in conformity with the Maryland General Corporation Law.

IN WITNESS WHEREOF, the Corporation has caused these presents to be signed in its name and on its behalf by its President and attested to by its Secretary, this 30<sup>th</sup> day of July, 2009. The undersigned President of the Corporation acknowledges under the penalties of perjury that these Articles of Amendment are the corporate act of the Corporation and that the matters and facts set forth herein are true in all material respects to the best of his knowledge, information and belief.
