ARTICLES OF AMENDMENT
TO CORPORATE CHARTER

Pursuant to the provisions of Section 48-20-106 of the Tennessee Business Corporation Act, the undersigned duly authorized representative of the Corporation hereby adopts the following Articles of Amendment to the Corporation's Charter:
