## ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS

This ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS (this "Assignment") is executed as of March 21, 2011 by U.S. BANK NATIONAL ASSOCIATION, a national banking association duly organized and existing under the laws of the United States of America ("US Bank"), in its capacity as collateral agent immediately prior to the effectiveness of the Removal Agreement (as defined below) (in such capacity, "Existing Collateral Agent") in favor of Successor Collateral Agent (as defined below). Capitalized terms used herein but not defined herein shall have the respective meanings assigned to such terms in the below-defined Indenture.

### WITNESSETH:

WHEREAS, Dole Food Company, Inc. (the "Issuer"), the Guarantors party thereto and US Bank entered into that certain Indenture dated as of March 18, 2009 (as amended, supplemented or otherwise modified to the date hereof and as it may hereafter be amended, supplemented or otherwise modified from time to time, the "Indenture");

WHEREAS, Issuer, certain of Issuer's subsidiaries party thereto and US Bank entered into that certain Security Agreement dated as of March 18, 2009 (as amended, supplemented or modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Issuer and certain of Issuer's subsidiaries party thereto, as applicable, entered into, each in favor of US Bank, (i) that certain Grant of Security Interest in United States Patents dated as of March 18, 2009, concerning the patents listed on Schedule 1 attached hereto (as amended, supplemented or modified from time to time, the "Patent Security Agreement"), (ii) that certain Grant of Security Interest in United States Trademarks dated as of March 18, 2009, concerning the trademarks listed on Schedule 2 attached hereto (as amended, supplemented or modified from time to time, the "Trademarks Security Agreement"), and (iii) that certain Grant of Security Interest in United States Copyrights dated as of March 18, 2009, concerning the copyrights listed on Schedule 3 attached hereto (as amended, supplemented or modified from time to time, the "Copyright Security Agreement"; the Patent Security Agreement, the Trademark Security Agreement and the Copyright Security Agreement are referred to herein collectively as, the "Intellectual Property Security Agreements");

WHEREAS, concurrently herewith, Existing Collateral Agent and Successor Collateral Agent are entering into that certain Instrument of Resignation, Appointment and Acceptance (the "Removal Agreement"), pursuant to which Existing Collateral Agent is being removed as Collateral Agent and the Issuer is appointing Deutsche Bank Trust Company Americas, a New York banking corporation, as successor Collateral Agent ("Successor Collateral Agent"); and

WHEREAS, in connection with the removal of Existing Collateral Agent, Successor Collateral Agent has requested that Existing Collateral Agent enter into this Assignment to assign all of its rights, title and interest in, to and under the Intellectual Property Security Agreements to Successor Collateral Agent.

NOW, THEREFORE, the parties hereto hereby agree as follows:

1. Assignment. Existing Collateral Agent, for good and adequate consideration, the receipt and sufficiency of which are hereby acknowledged, hereby assigns, without recourse, representation or warranty of any kind, as of the effectiveness of the Removal Agreement, to Successor Collateral Agent all of the rights, title and interest of Existing Collateral Agent in, to and under the Intellectual Property Security Agreements.

2. Further Assurances. Existing Collateral Agent agrees to cooperate with Successor Collateral Agent, at the sole cost and expense of the Issuer, and take all actions reasonably requested by Successor Collateral Agent in order to fully carry out the terms of this Assignment or to permit Successor Collateral Agent to obtain the full benefits of this Assignment.

3. Governing Law. This Assignment shall be governed by, and construed and enforced in accordance with, the laws of the State of New York without regard to principles of conflicts of laws.




