RESCISSION AGREEMENT

This **RESCISSION AGREEMENT** is effective as of the 7th day of August, 2008, by and between **OSI SUPPORT SERVICES, INC.**, a Wisconsin corporation, with an address at 180 North Executive Drive, Brookfield, Wisconsin, 53005 ("**ASSIGNOR**"), and **NCO HOLDINGS, INC.**, a Delaware corporation, with an address at 1201 Market Street, Suite 800, Wilmington, Delaware 19801 ("**ASSIGNEE**").

A. Assignor and Assignee are parties to that certain Assignment of Service Marks and Service Mark Registrations, dated as of August 7, 2008 (the "Assignment Agreement").

2. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same document.
