
**INTELLECTUAL PROPERTY ASSIGNMENT**

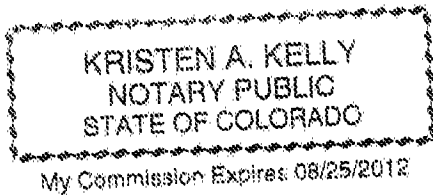
