RELEASE OF TRADEMARKS

This Release of Trademarks dated as of April 27, 2011 (this (“*Release*”) is made by **Credit Suisse, Cayman Islands Branch**, as administrative agent for Lenders (in such capacity, “*Administrative Agent*”) and as collateral agent for Lenders (in such capacity, the “*Secured Party*”), with an office at 11 Madison Avenue, New York, New York 10010, in favor of **NetIQ Corporation**, a Delaware corporation, with an office at 1500 Dexter Ave. N., Seattle, Washington 98109 (the “*Grantor*”).

WITNESSETH

WHEREAS, pursuant to a Grant of Trademark Security Interest dated June 30, 2006, recorded in the records of the United States Patent and Trademark Office on June 30, 2006, beginning at Reel 003340, Frame 0781 and IP Supplement dated January 30, 2008, recorded in the records of the United States Patent and Trademark Office on May 9, 2008, beginning at Reel 003775, Frame 0255 from the Grantor in favor of Secured Party, the Grantor granted to Secured Party, among other things, a continuing security interest in certain Trademarks set forth on Schedule 1 hereto (the “*Subject Trademarks*”), together with the goodwill associated therewith;

WHEREAS, pursuant to the terms of a First Lien Security Agreement dated as of June 30, 2006 (said First Lien Security Agreement, as it may have been amended, restated, supplemented or otherwise modified from time to time, being the “*First Lien Security Agreement*”), among Grantor, Secured Party and the other grantors named therein, Grantor created in favor of Secured Party a security interest in, and Secured Party has become a secured creditor with respect to, the Subject Trademarks;

WHEREAS, the Secured Party wishes to release all of its interest in the Subject Trademarks in the records of the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party does hereby release its security interest in, to or under all of the Subject Trademarks, together with the goodwill of the business symbolized thereby, and any right, title and interest of the Secured Party in, to and under the Subject Trademarks shall hereby cease and become void.
