INTELLECTUAL PROPERTY ASSIGNMENT

INTELLECTUAL PROPERTY ASSIGNMENT dated as of March 28, 2011 (this "Assignment"), by and among ICB Acquisitions, LLC, a Delaware limited liability company ("Purchaser"), Iron City Brewing, LLC, a Delaware limited liability company ("Seller"), and Pittsburgh Brewing Acquisition, LLC, a Delaware limited liability company ("Member," and together with Seller, "Sellers").

WHEREAS, Purchaser, Seller, Member and ICB Holdings, LLC, a Delaware limited liability company, have entered into that certain Asset Purchase Agreement, dated January 21, 2011 (the "Purchase Agreement"), pursuant to which Seller and Member have agreed, among other things, upon the terms and conditions set forth in the Purchase Agreement, to sell, assign, transfer, convey and deliver to Purchaser certain intangible assets owned by the Seller or the Member and used in the Business; and

WHEREAS, the parties desire to reflect, by the execution and delivery of this Assignment, the assignment and transfer by Sellers and the acceptance by Purchaser of such intangible assets, and have such assignment recorded with the United States Patent and Trademark Office and the Register of Copyrights of the United States.

NOW, THEREFORE, in consideration of the promises and the mutual covenants and agreements hereinafter contained, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. <u>Definitions</u>. Except as otherwise provided herein, all capitalized terms contained and not defined herein (including the recitals hereto) shall have herein the respective meanings ascribed to them in the Purchase Agreement.
- 2. <u>Assignment of Intellectual Property</u>. Upon the terms and subject to the conditions set forth in the Purchase Agreement, Sellers hereby sell, transfer, assign, convey and deliver to Purchaser, and Purchaser hereby accepts from Sellers, all right, title and interest in and to, together with the goodwill associated with the Business, the Registered Intellectual Property as set forth on <u>Exhibit A</u> and the assigned copyrights as set forth on Exhibit B.
- 3. Recordation of Assignment. Sellers hereby request and authorize the United States Patent and Trademark Office, and the Register of Copyrights of the United States, to record Purchaser as the owner of the Registered Intellectual Property and the assigned copyrights, and to issue all registrations for said Registered Intellectual Property and assigned copyrights, to be in the name of Purchaser, as assignee of the Registered Intellectual Property and assigned copyrights, for the sole use of Purchaser in accordance with the terms of this Assignment.
- 4. <u>Purchase Agreement</u>. This Assignment is executed and delivered pursuant to the Purchase Agreement and in all respects is subject to the covenants, representations, warranties and other provisions thereof. Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand or limit in any way the terms of the

Purchase Agreement. In the event of any conflict between the provisions of this Assignment and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement shall govern.

5. Miscellaneous.

- (a) <u>Successors and Assigns; Benefit and Binding Effect</u>. This Assignment shall inure to the benefit of and be binding upon the parties hereto and their respective successors and permitted assigns.
- (b) <u>Governing Law</u>. This Assignment shall be governed by, and construed in accordance with the laws of the State of New York, regardless of the applicable principles of conflicts of law thereof.
- (c) <u>Counterparts</u>. This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original but all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page of this Assignment by facsimile or by PDF file shall be as effective as delivery of a manually executed counterpart of this Assignment.
