AMENDMENT NO. 1 TO ASSET PURCHASE AGREEMENT

This Amendment No. 1 is made as of this 16 day of December, 2010, (the "AMENDMENT"), by and between Reisen Lumber Industries, Inc., a New Jersey corporation (hereinafter "SELLER"), 7400 County Road 146, P.O. Box 5499, Pagosa Springs, CO, 81147, and DER Specialty Products LLC, a New Jersey limited liability company (hereinafter "PURCHASER"), 178 Oak Ridge Avenue, Summit, NJ 07901 (each individually a "Party"; collectively the "Parties"), in accordance with Section 7.9 of the Asset Purchase Agreement dated October 5, 2010 by and between the SELLER and the PURCHASER ("ASSET AGREEMENT");

WITNESSETH

WHEREAS, the Parties entered into the ASSET AGREEMENT, dated October 5, 2010, pursuant to which the SELLER completed the winding up of its business affairs and agreed to sell, transfer and assign to the PURCHASER, all of the assets relating to the SELLER's Business; and

WHEREAS, pursuant to the ASSET AGREEMENT, the PURCHASER has agreed to acquire all of the assets relating to the SELLER's business as a manufacturer, distributor and seller of premier engineered wood flooring for new construction and/or major restoration projects, wherein certain of the SELLER's flooring was sold and distributed by the SELLER, under the common law trademark VIRTUTM; and

WHEREAS, the SELLER is the applicant for an intent-to-use ("ITU") trademark application for federal trademark registration covering the trademark VIRTU^{fM} (U.S. App. Serial No. 85-029630) for "wood and engineered wood flooring, excluding stair treads to fit over existing stairs," in International Class 019 ("630 Application); and

WHEREAS, the PURCHASER desires to acquire from the SELLER all right, title and interest in and to the trademark VIRTUTM, which is covered by and under the '630 Application, and resulting registration rights, and for all goodwill associated with the trademark VIRTUTM;

WHEREAS, the parties hereto desire to amend the ASSET AGREEMENT in certain respects for memorializing the assignment of all right, title and interest in and to the trademark VIRTUTM, which is covered by and under the '630 Application, and resulting registration rights, and for all goodwill associated with the trademark VIRTUTM, as set forth herein;

NOW THEREFORE, for and in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged pursuant to the ASSET AGREEMENT (Section 2), the Parties have now agreed to amend the ASSET AGREEMENT as set forth below;

- 1. A change to clause (d) and the addition of clause (e) shall be made to Section 5 of Exhibit A of the ASSET AGREEMENT (to which this AMENDMENT NO. 1 is attached) as follows:
 - (d) United States Patent and Trademark Office tTrademark registration aApplication Serial nNumber 85-029630, filed May 4, 2010 ("the '630 Application"). (the application to register the trademark VirtuTM). ; and

- (e) SELLER hereby assigns to PURCHASER all of the right, title and interest in and to the trademark VIRTUTM, and all goodwill associated therewith, said trademark covered by and under the '630 Application, and resulting registration rights therein, in perpetuity, for all countries, jurisdictions, and political entities of the world.
- 2. This AMENDMENT shall be considered an integral part of the ASSET AGREEMENT and shall be binding upon each party from the date first above written. Subject only to the modification referred to in this AMENDMENT, the ASSET AGREEMENT shall remain in full force and effect and where necessary shall be read and construed and be enforceable as if the terms of this AMENDMENT were inserted;
- 3. If any provision of this AMENDMENT shall be declared void or unenforceable by any judicial or administrative authority, the validity of another provision and of the entire AMENDMENT shall not be affected thereby;
- 4. The provision of Section 7.5 (Governing Law) of the ASSET AGREEMENT shall also apply to this AMENDMENT.
