TRADEMARK & INTELLECTUAL PROPERTY ASSIGNMENT

THIS TRADEMARK & INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment") is made and entered into as of May 17, 2011 (the "Effective Date") by and between George Clinton, an individual resident of the State of Florida ("Assignor"), and DUUDU LLC, a limited liability company, organized under the laws of the State of Florida ("Assignee").

WHEREAS, Assignor is the owner of all right, title, and interest to certain trademarks, service marks, and other intellectual property rights relating to merchandise, promotional material, and products associated with the FUNKADELIC®, PARLIAMENT®, and P-FUNK® musical groups, as more fully set forth on Schedule 1 attached hereto (collectively, the "Marks & Intellectual Property Rights"), together with any corresponding common law rights, analogous use rights, and rights of publicity, together with the goodwill of the business connected with and symbolized by the Marks & Intellectual Property.

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire and accept from Assignor, all right, title, and interest to the Marks & Intellectual Property Rights, including the right to sue for past infringements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. ASSIGNMENT & TRANSFER

Assignor hereby assigns, transfers, and conveys to Assignee its entire right, title and interest worldwide, including any common law rights, analogous use rights, and rights of publicity in the name, image, and likeness of George Clinton, together with the goodwill of the business connected with and symbolized by the Marks & Intellectual Property Rights, as well as any registrations and/or applications for registration before any governmental entity and all rights, claims and privileges pertaining to the foregoing and the rights referenced at Schedule 1, including all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks & Intellectual Property Rights and the right to collect all proceeds and damages therefrom.

2. EXPENSES AND MAINTENANCE

ASSIGNEE shall not be responsible for any costs, expenses or necessary maintenance prior to the date of execution of this Assignment, and ASSIGNOR shall not be responsible for any such costs, expenses or necessary maintenance incurred after the date of execution of this Assignment. ASSIGNEE shall bear the burden and expense of any recordation of this Assignment or other documents evidencing this transaction.

ASSISTANCE AND EXECUTION OF FURTHER DOCUMENTS

ASSIGNOR agrees to cause to be executed and delivered without further consideration any further applications, assignments or other documents, and to perform such other lawful acts as ASSIGNEE may reasonably require to fully secure and/or evidence the rights or interests herein or which is necessary to protect or enforce the Marks & Intellectual Property Rights.

4. SUCCESSORS AND ASSIGNS

This Assignment shall be binding on and inure to the benefit of the successors and assigns of the ASSIGNEE.

5. SEVERABILITY

The recitals and preamble language of this Assignment are part of the Assignment. If any part of this Assignment is held void, the remaining parts will not be affected.

6. WAIVER

Any waiver of a breach by either party shall not be waiver of any subsequent breach.

7. MODIFICATIONS

This Assignment may be changed only by written amendment signed by both parties.
