#### PARTIAL TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is executed as of June 1, 2011 by Bank of America, N.A., as administrative agent under the Security Agreement (as defined below) (the "Agent"), in favor of Gillette Transportation, LLC, a Nebraska limited liability company ("Gillette"), Goodrich Dairy Company, LLC, a Nebraska limited liability company ("Goodrich Dairy"), Goodrich Franchise, LLC, a Delaware limited liability company ("Goodrich Franchise"), It's The Cows, LLC, a Delaware limited liability company ("It's the Cows"), Kemps LLC, a Delaware limited liability company ("Marigold"), and Oak Grove Holdings, LLC, a Delaware limited liability company ("Oak Grove" and, together with Marigold, Kemps, It's the Cows, Goodrich Franchise, Goodrich Dairy, and Gillette, the "Released Parties").

The Agent hereby terminates, releases, and discharges its security interest in and first priority lien on the Released Trademarks, and the Agent hereby assigns and transfers to the Released Parties, without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest in and to the Released Trademarks together with the goodwill of the business symbolized thereby, including, without limitation, each of the trademarks applications or registrations identified on Schedule A attached hereto, effective as of the date set forth above.

This Release shall be governed by the laws of the State of New York and shall relate solely to the Released Trademarks subject to the Security Agreement.

The Agent understands and agrees that this Release may be recorded by or for the Released Parties with the USPTO or any similar office or agency within or outside the United States.
