TRADEMARK SECURITY AGREEMENT

(Trademarks, Trademark Applications and Trademark Licenses)

WHEREAS, (i) Weavexx, LLC, a Delaware limited liability company ("Weavexx"), (ii) Huyck Licensco Inc., a Delaware corporation ("Huyck"), (iii) Stowe Woodward LLC, a Delaware limited liability company ("Stowe"), (iv) Stowe Woodward Licensco LLC ("SW Licensco"), a Delaware limited liability company, and (v) Xerium Technologies, Inc., a Delaware corporation ("Xerium"; and together with Weavexx, Huyck, Stowe and SW Licensco, each, a "Lien Grantor") each located at 8537 Six Forks Road, Suite 300, Raleigh, North Carolina 27615, and such Lien Grantors, as applicable, own, or in the case of licenses, are parties to, the Trademark Collateral (as defined below);

WHEREAS, Xerium, Xerium Technologies Limited ("Euro Borrower," and together with Xerium, the "Borrowers"), certain subsidiaries of the Borrowers parties thereto, as Guarantors, the Banks from time to time parties thereto, Citibank, N.A., as Administrative Agent (together with its permitted successors, in such capacity, the "Administrative Agent"), and Citicorp North America, Inc., as Collateral Agent (together with its permitted successors, in such capacity, the "Collateral Agent"), among others, are parties to that certain Credit and Guaranty Agreement, dated as of May 26, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"; defined terms used herein but not otherwise defined shall have the meaning ascribed in the Credit Agreement), whereby the Banks have agreed to provide for revolving credit and term loan facilities on the terms and subject to the conditions set forth therein; and

WHEREAS, pursuant to (i) that certain Pledge and Security Agreement dated as of May 26, 2011 (as amended ,supplemented or otherwise modified from time to time, the "Security Agreement") among the Lien Grantors and the other parties named therein as Grantors and Citicorp North America, Inc., as Collateral Agent for the Secured Parties referred to therein (in such capacity, together with its successors in such capacity, the "Grantee"), and (ii) certain other Credit Documents (including this Trademark Security Agreement), each Lien Grantor has secured certain of its obligations (the "Secured Obligations") by granting to the Grantee for the benefit of such Secured Parties a continuing security interest in personal property of such Lien Grantor, including all right, title and interest of such Lien Grantor in and to the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Lien Grantor grants to the Grantee for the benefit of the Secured Parties (as defined in the Security Agreement), to secure the Secured Obligations, a continuing security interest in and to all of such Lien Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether now owned or existing or hereafter acquired or arising:

(i) each Trademark (as defined in the Security Agreement) owned by each Lien Grantor, including, without limitation, each Trademark referred to in <u>Schedule 1</u> hereto;

- (ii) each Trademark License (as defined in the Security Agreement) to which each Lien Grantor is a party; and
- (iii) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by each Lien Grantor against third parties for past, present or future infringement of any Trademark owned by each Lien Grantor (including, without limitation, any Trademark identified in Schedule 1 hereto).

Notwithstanding the foregoing, the Trademark Collateral shall not include and no Grantor shall be deemed to have granted a security interest in any applications to register Trademarks in the U.S. Patent and Trademark Office based on a Lien Grantor's "intent to use" such Trademark unless and until a Statement of Use or Amendment to Allege Use is filed therein, at which point such Trademark application shall be considered automatically included in the Trademark Collateral.

Each Lien Grantor hereby irrevocably appoints the Grantee as its true and lawful attorney, with full power of substitution, in the name of each Lien Grantor, the Grantee, the Secured Parties or otherwise, for the use and benefit of the Secured Parties, but at the Borrowers' expense, to the extent permitted by law to exercise, upon the occurrence and during the continuance of an Event of Default (as defined in the Credit Agreement) in accordance with the terms of the Credit Agreement and the Security Agreement, all or any of the powers with respect to all or any of the Trademark Collateral as set forth in the Credit Documents, including without limitation, the remedies set forth in Section 7 of the Security Agreement.

Each Lien Grantor acknowledges and affirms that the rights and remedies of the Grantee with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
