NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby acknowledges and agrees as follows:

1. Acknowledgment of Termination of Grants of Security Interest in Trademarks. All rights and security interest in the Trademarks, including but not limited to each

of the trademarks set forth in <u>Schedule I</u>, attached hereto and incorporated herein by reference, which were granted under the Grants of Security Interest recorded at the PTO on August 11, 2004 at Reel/Frame 3024/0771, on April 28, 2005 at Reel/Frame 3107/0916 and 3107/0905, and on January 18, 2006 at Reel/Frame 3251/0718 are hereby terminated and released and are no longer in force.

- All rights and security interest in the Patents, including but not limited to each of the patents set forth in Schedule II, attached hereto and incorporated herein by reference, which were granted under the Grants of Security Interest recorded at the PTO on August 11, 2004 at Reel/Frame 015661/0199, on April 28, 2005 at Reel/Frame 016174/0456 and 016172/0294, and on October 20, 2005 at Reel/Frame 017198/0477, are hereby terminated and released and are no longer in force.
- 3. Acknowledgment of Termination of Grants of Security Interest in Copyrights. All rights and security interest in the Copyrights, including but not limited to the copyrights set forth in Schedule III, attached hereto and incorporated herein by reference, which were granted under the Grants of Security Interest and recorded at the Copyright Office on August 16, 2004 at Microfilm V003513 P503, are hereby terminated and released and are no longer in force.
