**GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Agreement"), dated as of May 9, 2011 is made by **CAMBIUM LEARNING GROUP, INC.** ("Company"), a Delaware corporation, with offices at 17855 North Dallas Parkway, Suite 400, Dallas, Texas 75287, and each of the other entities listed on the signature pages hereof (together with the Company, the "Grantors") in favor of **WELLS FARGO BANK, NATIONAL ASSOCIATION**, with offices at MAC N9311-110, 625 Marquette Avenue, Minneapolis, Minnesota 55479, as Notes Collateral Agent (in such capacity, the "Agent") for the Secured Parties, in accordance with the Indenture, dated as of February 17, 2011 (as further amended, supplemented or otherwise modified from time to time, the "Indenture"), among Cambium Learning Group, Inc. (the "Issuer"), the guarantors from time to time party thereto and the Agent.

**W I T N E S S E T H:**

WHEREAS, pursuant to the Indenture, the Issuer has issued the Notes (as defined in the Indenture);

WHEREAS, in connection with the Indenture, the Issuer and certain other subsidiaries of the Issuer have executed and delivered a Security Agreement, dated as of February 17, 2011, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor has agreed to grant to the Agent for the benefit of the Secured Parties, a continuing security interest in all Intellectual Property, including, without limitation, the Trademarks; and

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Holders to Purchase the Notes, and to secure the Secured Obligations, the Grantor agrees, for the benefit of the Agent and the Secured Parties, as follows:

**SECTION 1. Definitions.** Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement.

**SECTION 2. Notice of Grant of Security Interest.** Pursuant to the Security Agreement, the Grantors assign and grant to the Agent, on behalf and for the benefit of the Secured Parties, and to secure the prompt and complete payment and performance of all Secured Obligations, a security interest in all of its right, title and interest in, to and under the Grantors' Trademarks (including, without limitation, those items listed on Schedule A hereto).

**SECTION 3. Purpose.** This Agreement has been executed and delivered by the Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Agent for the benefit of the Secured Parties in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The Security Agreement (and all rights and remedies of the Agent and the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. Grantors do hereby further acknowledge and affirm that the rights and remedies of the Agent and the Secured Parties with respect to the security interest in the Trademarks granted hereby are more fully set forth in the Indenture and the Security Agreement, the terms and provisions of which (including, without limitation, the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.






