RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 30, 2011 in favor of PlayCore Wisconsin, Inc., PlayCore Holdings, Inc. and PlayCore IP Sub, Inc. ("Grantors") by BNP Paribas, as administrative agent for the Lenders (in such capacity, "Secured Party").

WHEREAS, PlayCore Wisconsin, Inc. ("Company") entered into that certain Credit Agreement dated as of February 21, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") with the financial institutions named therein (collectively, together with their respective successors and assigns party to the Credit Agreement from time to time, the "Lenders") and Secured Party;

WHEREAS, Company, from time to time, entered or may have entered into one or more swap agreements (collectively, the "Lender Hedge Agreements") with one or more persons that were Lenders or affiliates of Lenders at the time such Lender Hedge Agreements were entered into (in such capacity, collectively, "Hedge Agreement Counterparties");

WHEREAS, certain of the Grantors entered into that certain Subsidiary Guaranty or Holdings Guaranty, as applicable, each dated as of February 21, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty") in favor of Secured Party for the benefit of Lenders and any Hedge Agreement Counterparties;

WHEREAS, pursuant to that certain Security Agreement dated as of February 21, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Grantors, Secured Party and the other grantors named therein, Grantors granted to Secured Party a security interest in all of its right, title and interest in, to and under certain intellectual property and, in connection therewith, entered into that certain Grant of Trademark Security Interest dated as of February 21, 2007 (the "Trademark Security Agreement") for the purpose of recording such security interest with respect to the trademark registrations and applications set forth on Schedule A hereto and such other assets included in the Trademark Collateral (as such term is defined in the Trademark Security Agreement) with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 2, 2007 at Reel 3521, Frame 0886; and

WHEREAS, Grantors have paid all of its outstanding indebtedness and all other Obligations (as defined in the Credit Agreement) to Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby, on behalf of itself and the Lenders (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all liens and security interests it has in, to and under the Trademark Collateral, (iii) re-assigns to Grantors any right, title and interest it may have in, to and under the Trademark Collateral, and (iv) authorizes and requests the United States Patent and Trademark Office, and any other location where the security interest was filed, to note and record the existence of such release hereby given.

Secured Party shall, at Grantors' expense, take all further actions, and provide to Grantors, its successors, assigns or other legal representatives, all such necessary cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
