#### RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of July 1, 2011 (this "Release") is made by Comerica Bank, as Agent, a Texas banking association (the "Secured Party") in favor of Gevity HR, Inc. (the "Debtor"). All initially capitalized terms used herein without definition shall have the meanings ascribed to them in the Trademark Security Agreement (defined below).

WHEREAS, pursuant to the Security Agreement dated as of June 1, 2009 (as amended, restated or otherwise modified from time to time, the "Security Agreement") and the Trademark Security Agreement dated as of June 1, 2009 (as amended, restated or otherwise modified from time to time, the "Trademark Security Agreement"), each by and among the Debtor and the Secured Party, the Debtor granted to the Secured Party a security interest in certain of the Debtor's intangible property, including the Intellectual Property Collateral, including but not limited to the Trademarks listed on attached Exhibit A.

WHEREAS, the Trademark Security Agreement was recorded in the records of the United States Patent and Trademark Office ("USPTO") on June 18, 2009 at Trademark Reel 004007, Frame 0090.

WHEREAS, the Secured Party wishes to: (i) release all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to the Debtor; and (iii) dissolve any and all liens and encumbrances respecting the Trademarks under the Security Agreement and the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby (a) terminates the Trademark Security Agreement and any other agreement under which the Debtor has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien or security interest in, to, and under the Intellectual Property Collateral, (b) cancels, discharges and releases the lien on and security interest in and the right, title, and interest in, to and under the Intellectual Property Collateral, including the Trademarks, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Intellectual Property Collateral, including the Trademarks, and (c) authorizes the recordation of this Release with the USPTO.
