This Termination of Security Interest in Copyrights and Trademarks (the "Termination") is executed on behalf of Brookside Mezzanine Fund II, L.P., as Agent (the "Agent"), in favor of Equitrac Corporation, a Florida corporation (the "Borrower"), and is effective as of July 14, 2011.

RECITALS

- A. Guarantors, a group which includes the Borrower, and the Secured Party entered into a certain Security Agreement, dated as of December 14, 2009 (the "Security Agreement").
- B. As required under the Security Agreement, the Guarantors and the Secured Party entered into a certain Copyright Security Agreement and a certain Trademark Security Agreement, each dated as of December 14, 2009.
- C. The grant of Security Interest in copyright collateral ("Copyright Collateral," as defined in the Copyright Security Agreement), relating to the Security Agreement, was filed with the U.S. Copyright Office on December 24, 2009 at V3585D511.
- D. The grant of Security Interest in trademark collateral ("Trademark Collateral," as defined in the Trademark Security Agreement), relating to the Security Agreement, was filed with the PTO on December 17, 2009 at Reel 004115/Frame 0568.
- E. Debtor has repaid all amounts due under the Security Agreement.

The Secured Party therefore expressly terminates its security interest in the Collateral, including without limitation, the Copyright Collateral listed on Schedule 1 and the Trademark Collateral listed on Schedule 2, each attached hereto.


