ASSIGNOR hereby assigns and transfers to ASSIGNEE the legal title to, and any and all of ASSIGNOR'S remaining rights, title, and interests in and to the PATENTS and TRADEMARKS, including any divisionals, continuations, reissues, reexaminations, and any foreign counterparts and applications based on the foregoing, and any and all improvements thereon, including the right to sue for present, past and/or future damages for infringement or otherwise, in the United States, its territorial possessions, and in all foreign countries and all treaty and convention rights;

Said PATENTS AND TRADEMARKS, and all rights thereto, to be held and enjoyed by the above-named ASSIGNEE, for ASSIGNEE'S own use, and for ASSIGNEE'S legal




