(i) Each trademark, trade name, corporate name, company name, business name, fictitious business name, trade style, service mark, logo, other business identifier, print or label on which any of the foregoing have appeared or will appear, all trademark registrations and recordings thereof, and all trademark applications in connection therewith, including, without limitation, the trademarks and applications listed on Schedule A hereto (including all renewals thereof), and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) All income, royalties, damages, payments and proceeds of the foregoing, including without limitation any claim by the Grantor against third parties for damages by reason of past, present or future infringement or dilution of any trademark, trademark registration and trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration and trademark application, in each case together with the right to sue for and collect said damages.
