**TERMINATION AND RELEASE
OF
TRADEMARK SECURITY INTEREST**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST** (“Termination and Release”), dated as of the date by which it is executed by Citicorp North America, Inc. (“Citicorp”), is made by Citicorp in connection with that certain Credit and Guaranty Agreement, dated as of May 26, 2011, by and between, among others, Citicorp and Weavexx, LLC, Huyck Licensco Inc., Stowe Woodward LLC, Stowe Woodward Licensco LLC, Xerium Technologies, Inc., Xerium III (US) Limited, Xerium IV (US) Limited, Xerium V (US) Limited, XTI LLC, Wangner Itelpa I LLC, and Wangner Itelpa II LLC (collectively, the “Lien Grantors”).

WHEREAS, effective as of May 19, 2005, the Lien Grantors granted to Citicorp certain security interests in, and undertook certain duties and obligations to Citicorp in connection with the United States trademark registrations and corresponding trademark registration applications set forth on Exhibit 1 hereto, which is incorporated by reference herein (“Exhibit 1”), and the respective marks related thereto, all of which such security interests, duties, and obligations are set forth in documents recorded with the Trademark Assignment Recordation Services Division of the United States Patent and Trademark Office (“USPTO”) at REEL 3160, FRAME 0139 as of July 18, 2005 (collectively, the “Security Interests”);

WHEREAS, Citicorp has terminated the Security Interests and agreed to release, relinquish and discharge all its right, title and interest therein; and

WHEREAS, Exhibit A to that certain Post-Closing Letter Agreement, dated May 26, 2011, by and among Citicorp, Xerium Technologies, Inc., and Xerium Technologies Limited requires the Lien Grantors to “file with the United States Patent and Trademark Office . . . releases or terminations of any and all unreleased security interests . . . , including the security interests in favor of [Citicorp] recorded in 2005.”

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Citicorp hereby agrees as follows:

1. Citicorp hereby releases, relinquishes and discharges in its entirety all its right, title and interest in the Security Interests.
2. Citicorp authorizes and requests the United States Patent and Trademark Office to record this Termination and Release.
3. This Termination and Release shall be governed by the law of the State of New York.


