TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, pursuant to the Purchase Agreement, Assignee desires to acquire all of Assignors' respective rights, title and interests in and to the Trademarks, together with the goodwill of the Business connected with and symbolized by the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. Each Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee, its successors and assigns, all of such Assignor's rights, title and interests in and to the Trademarks in the United States and all jurisdictions outside the United States, together with the goodwill of the Business connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, the right to bring an action for any and all past infringements of the rights being assigned and the right to collect and retain any proceeds therefrom, and any priority right that may arise from the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by such Assignor had this sale, assignment, transfer conveyance and deliverance not been made.
- 2. At and from time to time following the Closing, each Assignor shall take such actions as required by Section 7.18 (Further Assurances) of the Purchase Agreement in regard to this Trademark Assignment Agreement.
- 3. This Trademark Assignment Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an

original, but all of which when taken together shall constitute one and the same agreement. Each counterpart may be delivered by facsimile transmission or electronic transmission in portable document format, which transmission shall be deemed to be delivery of an originally executed document.
