- B. Reference is made to the Amended and Restated Guarantee and Collateral Agreement dated as of July 14, 2009 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), among Terex, the subsidiaries of Terex party thereto (together with Terex, the "Grantors") and the Collateral Agent. Pursuant to the Security Agreement, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the registered trademarks and trademark applications of the Grantors set forth on Schedule I hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office.
- C. In connection with the termination of the Existing Credit Agreement, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Secured Parties and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreement and the other Loan Documents.
