## NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Notice of Release of Security Interest in Trademarks ("Notice of Release") is made as of this 21<sup>st</sup> day of September, 2011, by GSG Fasteners, LLC, a Delaware Limited Liability Company of 1802 Scovill Drive, Clarksville, Georgia, 20523, which is a subsidiary of Global SFI Holdings, LLC, a Delaware Limited Liability Company of 620 Lookout Road, Boulder, Colorado, 80301, which acquired the assets of Scovill Fasteners Inc. ("Scovill") pursuant to an Order dated June 16, 2011 in Chapter 11 Case No. 11-21650 in the United States Bankruptcy Court, Northern District of Georgia, Gainesville Division (the "Bankruptcy Order"), the Assets having been declared free and clear of any and all encumbrances including those owned by General Electric Capital Corporation ("GECC"), a Delaware Corporation of 201 Merritt 7, 399 Main Avenue, Norwalk, Connecticut, 06856.

WHEREAS, GECC is a named lender and discharged creditor in the above-referenced Chapter 11 Case No. 11-21650;

WHEREAS, Scovill and GECC are parties to a security interest agreement executed May 12, 2010, which was recorded in the United States Patent and Trademark Office on May 17, 2010 at Reel No. 4207 and Frame No. 0645, pursuant to which Scovill granted to GECC a security interest in the trademarks listed on Schedule A attached hereto (the "Marks");

WHEREAS, all interest in the Marks including the security interest owned by GECC has been discharged pursuant to the Bankruptcy Order;

WHEREAS, Global SFI Holdings, LLC obtained the right to take all right, title and interest in the Marks owned by Scovill and the GECC security interest in the Marks owned by Scovill has been released under by the provisions of the Bankruptcy Order, as described in at least paragraphs 14 - 16 thereof; and

WHEREAS, following issuance of the Bankruptcy Order, Global SFI Holdings, LLC assigned its right to purchase and hold the assets of Scovill, including the Marks listed on Schedule A, to GSG Fasteners, LLC.

NOW, THEREFORE, as of on or about June 24, 2011, Scovill has assigned the Marks to GSG Fasteners, LLC free and clear of any and all encumbrances, including the security interest previously owned by GECC, which security interest has been discharged by the Bankruptcy Order as set for the herein.

The undersigned representative of GSG Fasteners, LLC, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, declares that he/she is properly authorized to execute this document on behalf of GSG Fasteners, LLC, and that the above statements are true to the best of his/her own knowledge, and that all statements made on information and belief are believed to be true.
