TRADEMARK ASSIGNMENT AGREEMENT

Assignor hereby transfers and assigns to Assignee its entire right, title and interest in and to the Marks, together with the goodwill associated therewith, including without limitation, all rights of action accrued, accruing and to accrue under and by virtue hereof, including the right to sue or otherwise recover for past infringement and receive all damages, payments, costs and fees associated therewith, and all registrations and applications for the Marks, including those set forth at Exhibit A.
- 2. This Assignment shall inure to the benefit of, and be binding upon the parties, their successors and assigns.
- 3. In the case of any conflict between the terms of this Assignment and the terms of the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall govern.
