ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS

This ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS (this "Assignment") is made as of the 30th day of April, 2004, by and among ROLLINS, INC., a Delaware corporation ("Assignee"), on the one hand; and WESTERN INDUSTRIES, INC., a New Jersey corporation, WESTERN EXTERMINATING COMPANY, INC., a New Jersey corporation, WESTERN EXTERMINATING CO., INCORPORATED, a Delaware corporation, WESTERN EXTERMINATING COMPANY OF ATLANTIC CITY, INC., a New Jersey corporation, WESTERN EXTERMINATING COMPANY OF DELAWARE, a Delaware corporation, WESTERN EXTERMINATING COMPANY OF FLORIDA, INC. a Florida corporation, WESTERN EXTERMINATING COMPANY OF MARYLAND, INC., a Maryland corporation, WESTERN EXTERMINATING COMPANY OF PENNSYLVANIA, a Pennsylvania corporation, WESTERN EXTERMINATING COMPANY OF VIRGINIA, INC., a Virginia corporation, JBD INCORPORATED, a Delaware corporation, WESTERN TERMITE & PEST CONTROL OF NORTH CAROLINA, INC., a North Carolina corporation, MEA REALTY CO., L.L.C., WEME ASSOCIATES, L.L.C., and WECO REALTY CORPORATION (collectively, "Assignor"), on the other hand.

RECITAL

A. Orkin, Inc., a Delaware corporation and a wholly-owned subsidiary of Assignee ("Orkin"), and Assignor are parties to an Asset Purchase Agreement dated as of March 8, 2004, and amended as of April 30, 2004 (the "Purchase Agreement"), pursuant to which Assignor has agreed to sell to Orkin or a Related Person of Orkin and Orkin has agreed to buy from Assignor the Assets, including without limitation the servicemarks, trademarks, trade names, and copyrights of Assignor.

B. Orkin and Assignee have entered into an Assignment and Assumption of Asset Purchase Agreement dated April 29, 2004 (the "Assignment Agreement"), pursuant to which Orkin has assigned to Assignee, and Assignee has accepted the assignment of, all of Orkin's rights and obligations under the Purchase Agreement with regard to the Intellectual Property Assets.

C. In accordance with the Purchase Agreement and the Assignment Agreement, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of:

(i) all of Assignor's worldwide right, title and interest in, to and under Assignor's Marks, including without limitation the Marks listed on Schedule A attached hereto and incorporated herein by reference ;

(ii) all of Assignor's worldwide right, title and interest in, to and under all of Assignor's Copyrights, including without limitation the Copyrights listed in Schedule B attached hereto and incorporated herein by this reference;

(iii) all of Assignor's worldwide right, title and interest in, to and under all of Assignor's mask words;

(iv) all of Assignor's worldwide right, title and interest in, to and under all of Assignor's Net Names, including without limitation the Net Names listed in Schedule C attached hereto and incorporated herein by this reference; and

(v) all of Assignor's worldwide right title and interest in, to and under all of Assignor's Trade Secrets.

ASSIGNMENT

NOW, THEREFORE, Assignor, for and in consideration of the payment of the purchase price set forth in the Purchase Agreement and the mutual covenants contained herein and in the Purchase Agreement and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of all of Assignor's worldwide right, title and interest in, to and under:

(a) the Marks, together with the goodwill of the business associated therewith and which is symbolized thereby;

(b) the Copyrights,

(c) Assignor's mask words;

(d) the Net Names; and

(e) the Trade Secrets,

(f) all rights to sue for infringement of any Mark, Copyright, Assignor's mask words or any Net Name, or misappropriation or disclosure of any Trade Secret, whether arising prior to or subsequent to the date of this Assignment, and any and all renewals and extensions of any Mark that may hereafter be secured by Assignee under the laws now or hereafter in effect in the United States, Canada and in any other jurisdiction,

the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment not been made.

Capitalized terms used but not defined herein shall have the meanings for such terms that are set forth in the Purchase Agreement.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment will be governed by and construed under the laws of the State of Georgia without regard to conflicts-of-laws principles that would require the application of any other law.

This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement. The exchange of copies of this Assignment and of signature pages by facsimile transmission shall constitute effective execution and delivery of this Assignment as to the parties and may be used in lieu of the original Assignment for all purposes. Signatures of the parties transmitted by facsimile shall be deemed to be their original signatures for all purposes.


The terms of the Purchase Agreement are incorporated herein by this reference. Assignor acknowledges and agrees that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded, enlarged or modified hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.
