TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Agreement") dated as of October 14, 2011, from Bank of America N.A., a National Banking Association, whose address is One Federal Street, Boston, MA 02110 ("Bank of America").

WITNESSETH:

WHEREAS, in connection with the Trademark Security Agreement dated July 31, 2009 ("Trademark Security Agreement"), Bank of America was granted a security interest in all of its right, title and interest in, to and under all Trademark Collateral (as defined in the Trademark Security Agreement) from Chelsea Industries, Inc. ("Grantor");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on August 4, 2009 at Reel 4037 and Frame 0132; and

WHEREAS, Bank of America now wishes to release its liens on, and security interests in, the Trademark Collateral (as set forth on Schedule A attached hereto).

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby states as follows:

- 1. <u>Release of Security Interest.</u> Bank of America hereby terminates, releases and discharges all of its security interest in the Trademarks, and reassigns any and all right, title and interest that it may have in or to the Trademarks to Grantor. This Agreement does not terminate, release or discharge the Bank of America security interest in any Intellectual Property of any grantor other than the Trademarks shown on Schedule A.
- 2. <u>Recordation</u>. Grantor or its authorized agent will record this Agreement with the United States Patent and Trademark Office.
- 3. <u>Governing Law</u>. This Agreement and the rights and obligations of the parties under this agreement shall be governed by, and construed and interpreted in accordance with, the law of Michigan, but giving effect to federal laws applicable to national banks.
