**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of November 1, 2011, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as US Agent (the "**US Agent**") and **GE CANADA FINANCE HOLDING COMPANY**, as Canadian Agent (the "**Canadian Agent**") and together with US Agent, the "**Agents**") under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement dated as of June 6, 2007 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements, patent security agreements and copyright security agreement entered into in connection therewith or in connection with prior versions thereof, the "**Credit Agreement**"), among **Lewis-Goetz and Company, Inc.** (the "**US Borrower**"), **Goodall Rubber Company of Canada ULC** (the "**Canadian Borrower**" and, together with the US Borrower, the "**Borrowers**"), the other Credit Parties signatory thereto, the US Agent, the Canadian Agent and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), the Lenders made credit extensions to the Borrowers;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrowers and the Credit Parties granted security interests in certain intellectual property owned by the Borrowers and the Credit Parties including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office and the U.S. Copyright Office on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Agents hereby **RELEASE**, without representation, recourse or warranty whatsoever, all of their security interests in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agents hereby reassign any and all such right, title and interest (if any) that the Agents may have in the Intellectual Property Collateral to the Borrowers and the Credit Parties, respectively.

Each Agent agrees, at the Borrowers' and the Credit Parties' reasonable expense, to cooperate with the Borrowers and the Credit Parties and to provide the Borrowers and the Credit Parties with the information and additional authorization reasonably required or desirable to effect the release of such Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


