INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of the 27th day of October, 2011 (as the same may be amended, supplemented, extended or restated from time to time, this "Agreement") is granted by TRAVELPRO INTERNATIONAL, INC. a Delaware corporation (including its successors and assigns, the "Grantor"), in favour of THE TORONTO-DOMINION BANK (including its successors and assigns, the "Lender").

RECITALS

WHEREAS, pursuant to, and subject to the terms and conditions set forth in that certain Credit Agreement dated as of the date hereof among the Grantor and HOLIDAY GROUP INC. as co-borrowers, HOLIDAY GROUP HOLDINGS INC., TRAVELPRO GP INC., TRAVELPRO FINANCE GP and TRAVELPRO ULC as guarantors and loan parties and the Lender as lender, (as the same may be amended, supplemented, restated or extended from time to time, the "Credit Agreement"), the Lender has agreed to extend certain loans, advances and other financial accommodations to the Grantor;

AND WHEREAS, the obligations of the Lender to extend and provide such loans, advances and other financial accommodations to the Grantor under the Credit Agreement are conditioned upon, among other things, the execution and delivery of the general security agreement dated as of the date hereof between the Grantor and Lender (the "General Security Agreement");

AND WHEREAS pursuant to the General Security Agreement, the Grantor has granted a security interest in the Grantor's intellectual property to the Lender.

AGREEMENT

NOW, THEREFORE, in consideration of the premises and the mutual covenants hereinafter contained and for other valuable consideration (the receipt and sufficiency of which is hereby acknowledged by the Grantor), the Grantor agrees as follows:

1. Definitions. Initially capitalized terms used but not defined in this Agreement have the same meanings as in the General Security Agreement.
2. Grant of Security Interest in Intellectual Property. As general and continuing collateral security for the prompt and complete payment and performance of the Secured Obligations, the Grantor hereby grants to the Lender, a security interest in and Lien on all of the Grantor's right, title and interest in its registered and unregistered intellectual property (the "IP Security Interest"), which intellectual property includes, without limitation, the intellectual property set forth on Schedule "A" attached hereto and the following (collectively, the "IP Collateral"):
 - (a) any and all copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter acquired or held;
 - (b) any and all trade secrets, and any and all property rights in computer software and computer software products, including source code and object code, now or hereafter acquired or held. Software means all computer programs and databases and portions of each of the foregoing owned by the Grantor in whatever form and on whatever medium

those programs or databases are expressed, fixed, embodied or stored from time to time, and the copyright therein including. Software includes both the object code and the source code versions of each such program and portions thereof and all corrections, updates, enhancements, translations, modifications, adaptations and new versions thereof together with both the media upon or in which such programs, databases and portions thereof are expressed, fixed, embodied or stored (such as disks, diskettes, tapes and semiconductor chips) and all flow charts, manuals, instructions, documentation and other material relating thereto;


- (c) all patents, patent applications, like protections and inventions now or hereafter acquired or held including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same;
 - (d) any trademark and service mark rights, slogans, trade dress, and tradenames, internet domain names, registered or not, applications to register and registrations of the same and like protections (excluding any intent to use filings) now or hereafter acquired or held, and the entire goodwill of the business of the Grantor associated therewith;
 - (e) any and all industrial design rights which may be available to the Grantor now or hereafter acquired or held;
 - (f) all licenses or other rights to use any of the above-described copyrights, patents, software, designs, trademarks, trade secrets, and all license fees and royalties due and/or payable to the Grantor arising from such use, to the extent permitted by such license or rights;
 - (g) any and all claims for damages or compensation for past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;
 - (h) all amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks, Patents or Designs; and
 - (i) all proceeds and products of the foregoing including, without limitation, all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.
3. Security Agreement. The IP Security Interest is granted in conjunction with the security interests granted to Lender under the General Security Agreement and Grantor hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the IP Security Interest in the IP Collateral are more fully set forth in the General Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the General Security Agreement, the provisions of the General Security Agreement shall control.
4. Additional Agreements. To the extent that the Security Interest would constitute a breach or cause the acceleration of any agreement, contractual right, licence or permit to which the Grantor is a party, the Security Interest shall not attach thereto but the Grantor shall hold its interest therein in trust for the Lender, shall use its best efforts to obtain the appropriate consents to the attachment of said security interest and shall grant a security interest in such agreement, contractual right, licence or permit to the Lender forthwith upon obtaining the appropriate consents to the creation of such security interest.

5. Governing Law. This Agreement will be governed by and construed in accordance with the laws of the State of New York without regard to the conflict of law rules thereof other than Section 5-1401 of the New York General Obligations Law. The Grantor submits and attorns to the non-exclusive jurisdiction of the courts of the State of New York. To the extent permitted by Law, the Grantor irrevocably waives any objection (including any claim of inconvenient forum) that it may now or hereafter have to the venue of any legal proceeding arising out of or relating to this Agreement in courts of such province.
6. Electronic Signature. Delivery of this Agreement by electronic transmission (including portable document format (PDF), facsimile and other electronic transmissions) shall be deemed to constitute valid execution and effective delivery. The Grantor shall deliver the original executed copy of this Agreement to the Lender forthwith upon delivery of the electronic copy.
7. Copy Received; Grantor Remains Liable. The Grantor acknowledges receipt of a copy of this Agreement. The Grantor hereby agrees that, the Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other reasonably necessary or desirable actions in connection with the IP Collateral subject to a security interest hereunder.
8. Update Schedule. The Grantor hereby covenants and agrees that it shall promptly provide the Lender with an updated Schedule A at each time when the Grantor acquires or holds any IP Collateral not listed on Schedule A attached herewith.
