TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 4, 2011, is made by Bank of America, N.A., as administrative agent (the "Secured Party") in favor of LifeCell Corporation ("Grantor").


