INTELLECTUAL PROPERTY SECURITY RELEASE

THIS INTELLECTUAL PROPERTY SECURITY RELEASE (this "Release") is made as of this 4th day of November, 2011, by Deutsche Bank AG New York Branch, as collateral agent ("Collateral Agent"), in favor of the entities listed on Schedule A (collectively, the "Releasees").

WHEREAS, Building Materials Corporation of America, a Delaware corporation (the "Company"), together with certain of its Subsidiaries, has entered into a Junior Lien Term Loan Agreement (amending and restating in its entirety the Bridge Loan Agreement dated as of February 22, 2007, the "Existing Bridge Loan"), dated as of March 15, 2007 (the "Loan Agreement"), with Deutsche Bank AG New York Branch, as Collateral Agent, and certain other parties listed on the signature pages thereto. The Loan Agreement amended and restated in its entirety the Existing Bridge Loan and Collateral Agent has replaced Deutsche Bank AG Cayman Islands Branch as the collateral agent and administrative agent under the Existing Bridge Loan. The Lenders and Agents party to the Loan Agreement are the "Secured Parties" hereunder.

WHEREAS, the Company and certain of its Subsidiaries have entered into a Term Loan Agreement dated as of February 22, 2007 (as amended, restated, waived or otherwise modified, refinanced or replaced from time to time, the "Term Loan Agreement") with the lenders party thereto, Deutsche Bank AG New York Branch, as administrative agent, the Deutsche Bank Securities Inc., Bear Stearns & Co. Inc., and J.P. Morgan Securities Inc., as joint lead arrangers and joint book managers, Bear Stearns & Co. Inc., as syndication agent, and J.P. Morgan Securities Inc., as documentation agent for the lenders.

WHEREAS, the Company is a party to the Revolving Credit Agreement dated as of February 22, 2007 (as amended, restated, supplemented, waived or otherwise modified, refinanced or replaced from time to time, the "Revolving Credit Agreement") among the Company and certain of its Subsidiaries, the lender parties party thereto, Deutsche Bank AG New York Branch, as collateral monitoring agent and administrative agent, swingline lender and letter of credit issuer, Bear Stearns & Co. Inc., as syndication agent, J.P. Morgan Securities Inc., as documentation agent, and Deutsche Bank Securities Inc., Bear Stearns & Co., Inc. and J.P. Morgan Securities Inc., as joint lead arrangers and joint book managers.

WHEREAS, the Company was a party to (i) an indenture dated as of October 20, 1997 (as amended, restated, supplemented, waived or otherwise modified, refinanced or replaced from time to time, the "2007 Notes Indenture"), among the Company, the Guarantors identified therein and The Bank of New York, as trustee pursuant to which certain 8% senior notes due 2007 (the "2007 Notes") were issued; (ii) an indenture dated as of December 3, 1998 (as amended, restated, supplemented, waived or otherwise modified, refinanced or replaced from time to time, the "2008 Notes Indenture"), among the Company, the Guarantors identified therein and The Bank of New York, as trustee pursuant to which certain 8% senior notes due 2008 (the "2008 Notes") were issued; and (iii) an indenture dated as of July 26, 2004 (as amended, restated, supplemented, waived or otherwise modified, refinanced or replaced from time to time, the "2014 Notes Indenture" and together with the 2007 Notes Indenture and the 2008 Notes Indenture, the "Terminated Indentures"), among the Company, the Guarantors

identified therein and Wilmington Trust Company, as trustee pursuant to which certain 7.75% senior notes (the “2014 Notes”) were issued.

WHEREAS, the Company is a party to an indenture dated as of February 5, 2010 (as amended, restated, supplemented, waived or otherwise modified, refinanced or replaced from time to time, the “2020 Notes Indenture”) among the Company, the Guarantors identified therein and Wilmington Trust Company, as trustee pursuant to which certain 7% senior secured notes due 2020 were issued.

WHEREAS, Deutsche Bank AG New York Branch as Collateral Agent under the Term Loan, The Bank of New York, as trustee under the 2007 Notes Indenture and the 2008 Notes Indenture, and Wilmington Trust Company, as trustee under the 2014 Notes Indenture and the 2020 Notes Indenture, the Company and the other Releasees are party to the Collateral Agency Agreement dated February 22, 2007 (as amended, restated, supplemented, waived or otherwise modified or replaced from time to time (the “Collateral Agency Agreement”) in which the parties thereto have appointed Deutsche Bank Trust Company Americas as Collateral Agent on behalf of the parties thereto.

WHEREAS, each Releasee has executed and delivered those certain security agreements dated February 22, 2007 made by the Releasees to the Collateral Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreements”).

WHEREAS, under the terms of the Security Agreements, the Releasees have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Releasees, including the Patents (as defined below) owned by the Releasees and set forth on Schedule B and certain Trademarks (as defined below) owned by the Releasees and set forth on Schedule C and the Releasees executed as a condition thereof an Intellectual Property Security Agreement, dated March 15, 2007 and recorded with the United States Patent & Trademark Office on (i) April 5, 2007 at Reel 3516 and Frame 0575 with respect to Trademarks and (ii) April 5, 2007 at Reel 019122 and Frame 0197 with respect to Patents (the “Security Interest”);

WHEREAS, Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby states as follows:

1. Definitions.

(a) The term “Collateral” shall mean all of each Releasee’s right, title and interest to and under the following:

(i) the patents and patent applications set forth in Schedule B hereto (the “Patents”);

(ii) the trademark and service mark registrations and applications set forth in Schedule C hereto, together with the goodwill symbolized thereby (the “Trademarks”);

(iii) [all copyrights, whether registered or unregistered, owned by such Releasee, including, without limitation,] the copyright registrations and applications and exclusive copyright licenses set forth in Schedule D hereto (the “Copyrights”);

(iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Releasee accruing thereunder or pertaining thereto;

(v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.

2. Release of Security Interest. Collateral Agent hereby unconditionally and expressly releases, terminates, discharges and extinguishes its Security Interest in the Collateral, and any and all of its right, title and interest in, to and under the Collateral shall hereby cease and become void.


3. Further Assurances. Collateral Agent hereby consents and agrees to execute and deliver, at the request and cost of Releasees, such further instruments, documents and release forms as Releasees may reasonably request to more effectively release, terminate, discharge or extinguish the Security Interest contemplated hereby.


4. Recordation. The Collateral Agent authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Intellectual Property Security Release.
