## **TRADEMARK RIGHTS RELEASE**

TRADEMARK RIGHTS RELEASE, effective as of this 18 day of November, 2011, given by JPMORGAN CHASE BANK, N.A., as Collateral Agent ("Agent"), to THE BERRY COMPANY LLC, a Colorado limited liability company (successor to Local Insight Yellow Pages, Inc. and Local Insight Berry Holdings, LLC) ("Grantor"), as follows:

### **WITNESSETH**

WHEREAS, pursuant to that certain Credit Agreement, dated as of April 23, 2008 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders (as defined in the Credit Agreement) have agreed to extend credit to the Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Grantor granted to the Agent a security interest in certain United States trademarks, trademark registrations, trademark applications and exclusive trademark licenses more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in that certain Guaranty and Collateral Agreement, dated as of April 23, 2008, between the Agent and the Grantor (as amended, supplemented or otherwise modified from time to time, the "Security Agreement")), created pursuant to the Security Agreement;

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Trademark Security Agreement, dated April 23, 2008 (the "Trademark Security Agreement"), which was duly recorded on April 28, 2008, at Reel 3767 / Frame 688 in the United States Patent and Trademark Office;

WHEREAS, the Agent executed a Confirmation of Security Interest in Trademark Collateral, dated September 20, 2010 (the "Confirmation"), which was duly recorded on September 20, 2010, at Reel 4281 / Frame 0804 and at Reel 4281 / Frame 0833 in the United States Patent and Trademark Office;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Marks to the Grantor and to dissolve any and all Liens and encumbrances created by the Security Agreement, the Trademark Security Agreement and the Confirmation in respect of the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, releases, discharges, quit claims and relinquishes unto the Grantor the security interest in the Marks set forth on Schedule A and created by the Security Agreement, the Trademark Security Agreement and the Confirmation.
