TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of October 11, 2011, is by and among ScanSource, Inc., a South Carolina corporation ("ScanSource"), Netpoint International, Inc., a Florida corporation ("Netpoint", and, together with ScanSource, are sometimes collectively referred to herein as "Grantors" and individually as a "Grantor"), and JPMorgan Chase Bank, N.A. (the "Secured Party"), as collateral agent for the benefit of the Secured Creditors.

WITNESSETH:

WHEREAS, each Grantor has entered into that certain Security Agreement dated as of September 28, 2007 (as amended, restated, modified or supplemented from time to time, the "Security Agreement") with the Secured Party, for itself and the other Secured Creditors, pursuant to which such Grantor has granted to Secured Party a security interest in substantially all the assets of such Grantor, including all right, title and interest such Grantor in, to and under all now owned and hereafter acquired Trademarks and Trademark licenses, together with the goodwill of the business symbolized by such Grantor's Trademarks, and all products and proceeds thereof, (collectively, the "Trademarks") to secure the payment of the Obligations;

WHEREAS, capitalized terms used but not defined herein are used in the manner provided in the Security Agreement;

WHEREAS, each Grantor owns its respective Trademarks listed on Schedule 1 annexed hereto, and is a party to the Trademark licenses listed on Schedule 1 annexed hereto; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor does hereby grant to Secured Party a continuing security interest in all of such Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether presently existing or hereafter created or acquired:

- (1) each of the Trademarks, including without limitation, each Trademark referred to in Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each of the Trademarks;
- (2) each Trademark license, including, without limitation, each Trademark license listed on Schedule 1 annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark license; and
- (3) all products and proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future (a) infringement of any Trademark, including, without limitation, any Trademark referred to in Schedule 1 annexed hereto and any Trademark licensed under any Trademark license listed on Schedule 1 annexed hereto, or (b) injury to the

goodwill associated with any Trademark or Trademark licensed under any Trademark license.

This security interest is granted in conjunction with the security interests granted to Secured Party pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
