THIS TRADEMARK RELEASE (this "Release"), made as of October 19, 2011 by WELLS FARGO CAPITAL FINANCE, LLC (as successor by merger to Wachovia Capital Finance Corporation (Central)), as Administrative Agent

WITNESSETH:

WHEREAS, pursuant to certain trademark security agreements and other related financing documents (the "Security Agreements"), La-Z-Boy Incorporated, a Michigan corporation ("Parent"), the subsidiaries of Parent party thereto (each a "Subsidiary Borrower" and, collectively, the "Subsidiary Borrowers", and together with Parent, each a "Grantor" and collectively, "Grantors") has granted to Administrative Agent a security interest in all of Grantors' right, title and interest in, to and under the following, whether then existing or thereafter created or acquired (collectively, the "Trademark Collateral"):

WHEREAS, the Security Agreements were recorded with the United States Patent and Trademark Office at Reel 003717 Frame 0873; Reel 003818 Frame 0038; Reel 003999 Frame 0173; and Reel 004531 Frame 0710; and

WHEREAS, at the request of the Grantors, Administrative Agent has agreed to release its security interest in the Trademarks and the other Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby releases any and all claims, liens, and other encumbrances in and to the Trademarks and all other trademarks with respect to which the Security Agreements were so recorded and all other Trademark Collateral, and Administrative Agent reassigns any and all rights, titles and

interests therein, without any representation, recourse or undertaking by Administrative Agent, to the Grantors.
