THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "*Trademark Termination and Release*") dated as of November 16, 2011, from CAPITAL ONE, NATIONAL ASSOCIATION, a national banking association, in its capacity as administrative agent (the "*Administrative Agent*") pursuant to a Trademark Security Agreement (the "*Security Agreement*") dated as of March 24, 2009 among SAZERAC NORTH AMERICA, INC., BARTON DISTILLERS IMPORT CORP., BARTON BRANDS OF CALIFORNIA, INC. (each a "*Grantor*" and collectively, the "*Grantors*") and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement dated as of March 24, 2009, a security interest (the "*Security Interest*") was granted by the Grantors to the Administrative Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 15, 2009 at **Reel 003988, Frame 0955**; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "*Trademark Collateral*", as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademark Collateral (as defined in the Security Agreement), including, without limitation, those items listed on Exhibit A hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature.
